The Stewards, having received two reports from the Race Director, summoned and heard from driver Loris Hezemans and competitor's representative Gottfried Grasser, have considered the following matter and determine the following:

**No. / Driver:** 82 / Loris Hezemans  
**Competitor:** GRT Grasser Racing Team  
**Time:** 15.04 hrs  
**Session:** Free Practice 2  
**Facts:** Speeding in the pit lane with 65.3 kph  
**Offence:** Breach of Article 139 of the Blancpain GT Series 2018 Sporting Regulations  
**Decision:** **Fine €765 and 1 Behaviour Warning Point**  
**Reason:** Timekeeping data (two reports) shows that the driver exceeded the pit lane speed limit of 50kph during Free Practice 2. The Stewards therefore impose a fine in accordance with Article 139 of the Blancpain GT Series 2018 Sporting Regulations and, considering the speed of 65.3 kph but slowing quickly from pit entry, one Behaviour Warning Point in accordance with Article 56 of the Blancpain GT Series 2018 Sporting Regulations

The Competitor is reminded of his right of appeal in accordance with Article 15 of the 2018 FIA International Sporting Code.
