The Stewards, having received three reports from the Race Director, summoned and heard from driver Claude-Yves Gosselin and competitor's representative Amaury Lainé, have considered the following matter and determine the following:

No. / Driver: 15 / Claude-Yves Gosselin
Competitor: Boutsen Ginion Racing
Time: 15.28 hrs
Session: Free Practice 2
Facts: Speeding in the pit lane with 57.8 kph
Offence: Breach of Article 139 of the Blancpain GT Series 2018 Sporting Regulations
Decision: **Fine €390 and 1 Behaviour Warning Point**
Reason: Timekeeping data (three reports) show that the driver exceeded the pit lane speed limit of 50kph during Free Practice 2 at pit lane exit. The Stewards heard that the driver misunderstood which pit exit line was in force but determine that a fine is appropriate in accordance with Article 139 of the Blancpain GT Series 2018 Sporting Regulations and, considering the speed of 57.8 kph, one Behaviour Warning Point in accordance with Article 56 of the Blancpain GT Series 2018 Sporting Regulations

The Competitor is reminded of his right of appeal in accordance with Article 15 of the 2018 FIA International Sporting Code.

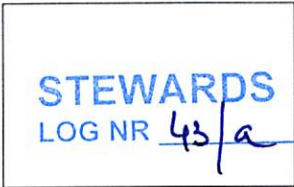

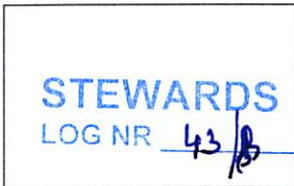
