**Facts:** Speeding in the pit lane with 53.3 kph  
**Offence:** Breach of Article 139 of the Blancpain GT Series 2018 Sporting Regulations  
**Decision:** **Fine €165 and 1 Behaviour Warning Point**  
**Reason:** Timekeeping data shows that the driver exceeded the pit lane speed limit of 50kph during Free Practice. The Stewards therefore impose a fine in accordance with Article 139 of the Blancpain GT Series 2018 Sporting Regulations and, considering the speed of 53.3 kph, one Behaviour Warning Point in accordance with Article 56 of the Blancpain GT Series 2018 Sporting Regulations


The Competitor is reminded of his right of appeal in accordance with Article 15 of the 2018 FIA International Sporting Code.

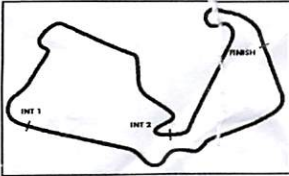
