Session: Qualifying
Facts: Speeding in the pit lane with 56.4 kph
Offence: Breach of Article 139 of the Blancpain GT Series 2018 Sporting Regulations
Decision: **Fine €320 and 1 Behaviour Warning Point**
Reason: Timekeeping data shows that the driver exceeded the pit lane speed limit of 50kph during Qualifying. The Stewards therefore impose a fine in accordance with Article 139 of the Blancpain GT Series 2018 Sporting Regulations and, considering the speed of 56.4 kph, one Behaviour Warning Point in accordance with Article 56 of the Blancpain GT Series 2018 Sporting Regulations.

The Competitor is reminded of his right of appeal in accordance with Article 15 of the 2018 FIA International Sporting Code.

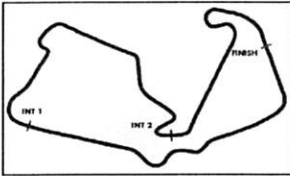
