The Stewards, having received a report from the Race Director, have considered the following matter:

- #/Driver: 63/Mirko Bortolotti
- Competitor: GRT Grasser Racing Team
- Report: In Q1 car #63 left track at T8 and hit tyre wall resulting in Red Flag with the session not restarting.
- Offence: Alleged breach of Article 41.10 of the 2019 Blancpain GT Sporting Regulations
- Investigation: The Stewards summons the driver and Team Manager. The Stewards considered the video captured from the live TV broadcast and a record of all lap time of car #63 in Q1. In their consideration, the Stewards were also assisted by the Stewards' Driver Advisor.
- Facts: At approximately 16.30hrs in Q1, car #63 left the track at T8 and made contact with the barrier on the outfield causing damage to the car. The car was on its 13th lap of the session when the incident occurred. It was noted that the car's 11th lap had thus far been its fastest. The driver advised the Stewards that his 12th lap was a slow lap (confirmed by lap times) which he anticipated would restore the car's tyre pressures and give him his best opportunity for his best lap on what would be his 13th lap of the session. It was noted that the incident occurred almost at the end of the session with the Red Flag being declared 1.032 seconds before the chequered flag would have been displayed.

Decision: Having considered all the evidence and testimony, the Stewards are not satisfied that there was a breach of Article 41.10 and make no order.

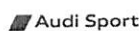
