The Stewards, having received a report from the Race Director, have considered the following matter and determine the following:

Car No: 107 Driver: NELSON PANCIATICI

Facts:

- Crossed the white line at pit lane: entry  exit
- Exceeded the speed limit in the pit lane with a speed of 58.4 km/h
- Did not respect yellow flags  repeatedly
- Did not respect track limits  repeatedly
- Made a false start
- Caused a collision
- Forced a driver off the track
- Illegitimately impeded another driver during overtaking
- Pit lane infringement .....
- Other .....

Offence:

- Breach of Article 34.11 of the GT Challenge Europe Sporting Regulations
- Breach of Article ..... of the FIA International Sporting Code

Decision:

Reason: TIMEKEEPING DATA SHOWS CAR 107 CROSSED THE 'PIT FINISH' TIMING LOOP AT A SPEED 8.4 KPH IN EXCESS OF THE 50 KPH PIT LANE SPEED LIMIT. NOTING THAT THE CAR IS NOW RETIRED FROM THE RACE, A REPRIMAND IS IMPOSED + 1 BWP.
