1. Driver Categorisation Derogations

In accordance with Article 10.4 of the Fanatec GT Challenge Europe powered by AWS Sporting Regulations, the SRO Sporting Board has decided the following temporary categorisation derogations which are applicable to this competition, together with associated additional penalty weights where these have been determined to be appropriate.
