Facts:

- Crossed the white line at pit lane: entry  exit
- Exceeded the speed limit in the pit lane with a speed of \_\_\_\_\_ km /h
- Did not respect yellow flags  repeatedly
- Did not respect track limits  repeatedly
- Made a false start
- Caused a collision
- Forced a driver off the track
- Illegitimately impeded another driver during overtaking

- Breach of Article 33.4 / 33.10 of the Fanatec GT Challenge Europe powered by AWS Sporting Regulations
- Breach of Article App L Ch IV 2c) of the FIA International Sporting Code
