The Stewards, having received a report from the Race Director, have considered the following matter and determine the following:

**Facts:**

- Crossed the white line at pit lane: entry  exit
- Exceeded the speed limit in the pit lane with a speed of \_\_\_\_\_ km/h
- Did not respect yellow flags  repeatedly
- Did not respect track limits  repeatedly
- Made a false start
- X Caused a collision
- Forced a driver off the track
- Illegitimately impeded another driver during overtaking
- Pit lane infringement .....

**Reason:** Car #111 was attempting to pass car #18 at T6. In so doing, car #111 fully left the track at the apex of T6. The trajectory of car #111 brought it into collision with car #18 forcing #18 off-track at the exit of T6 and resulting in a spin. Car #18 subsequently retired. The Stewards find that driver of car #111 is responsible for this collision.....
