The Stewards, having received a report from the Race Director, have considered the following matter and determine the following:

Car No: # 55 Driver: Barker

Facts:

- Crossed the white line at pit lane: entry  exit
- Exceeded the speed limit in the pit lane with a speed of \_\_\_\_\_ km/h
- Did not respect yellow flags  repeatedly
- Did not respect track limits  repeatedly
- Made a false start
- Caused a collision
- Forced a driver off the track
- Illegitimately impeded another driver during overtaking
- Pit lane infringement .....
- Other...Car #55 was in the fast lane before the "Fast Lane Open" signal was given or the pit lane exit was green

Offence:

- Breach of Article 34.15 of the Fanatec GT Challenge Europe powered by AWS 2023 Sporting Regulations
- Breach of Article \_\_\_\_\_ of the FIA International Sporting Code

Decision:

- Fine \_\_\_\_\_ Euros
- Drive-through penalty  converted to time penalty \_\_\_\_\_ seconds
- Stop-and-go penalty  \_\_\_\_\_ seconds  converted to time penalty \_\_\_\_\_ seconds
- Time penalty \_\_\_\_\_ seconds  to be served at next pit stop  to be added to the elapsed race time
- Cancellation of:  lap time of infringement  fastest lap time in session
- Cancellation of all lap times in session  up to \_\_\_\_\_ hrs
- Black flag to be shown
- Behaviour Warning Point(s)
- No further action
- Other..... **Reprimand to the Competitor**

Reason: Car #55 was released into the fast lane too early. Having heard from the competitor's representative, it is accepted that this is a breach of the above regulation. Noting that no competitive advantage was gained and that this is the first such break from the competitor, the Stewards impose a Reprimand in this instance.
