

The Stewards, having received request from the Competitor and an endorsement form the SRO Sporting Board, and having considered the following matter, determine the following:


Car 100
Competitor Attempto Racing
Facts Due to the absence of driver Jeroen Mul, the competitor requests that car 100 be allowed to race in the Pro-Am Cup with only the two drivers Max von Splunteren (Silver) and Louis Machiels (Bronze).
Decision The request is approved. However, because the Q3 qualifying time was set by the driver who will not now take part in the race, the qualifying time for car 100 is annulled and the car must therefore start the race from the back of the grid.

In accordance with Article 40 b) of the 2016 Blancpain GT Series Sporting Regulations, Driver 1 will be null, Louis Machiels will be considered Driver 2 and Max von Splunteren will be considered Driver 3. The competitor is reminded that Max von Splunteren has a maximum driving time of 65 minutes (one complete stint) during the race.

The competitor was granted a hearing before the decision.

According to Article 40 b) of the 2015 Sporting Regulations :
"In the Blancpain Endurance GT Pro-Am Cup and Blancpain Endurance GT Am Cup, two drivers may be allowed to compete for a team, subject to the approval of the SRO Sporting Board. In Pro-Am, one driver must be categorised as Bronze. Driver 1 will be null, the Bronze driver must be considered as Driver 2 in terms of these regulations and the remaining driver will be considered as Driver 3. The car will only compete in Q2 and Q3. "

Due to the absence of driver Jeroen Mul, the following request has been received for the nr 100 Attempto Racing car in the Pro-Am Cup, with the driver line-up as follows :


Max von Splunteren	Silver
